3. Public can download the applications and register any complaints or grievances through text, photographs, video or voice with GPS for locational details. The complaints shall be forwarded to the right authorities & elected representatives for initiating actions. If the concerned Government authority & elected representatives (Village Panchayat members or Corporator) fails to deliver within the stipulated time span (The concerned authority & representative shall own the failures & will be held responsible for it) then the complaint shall get escalated to higher authorities and people representatives (MLA). The complaints will have to be closed within the stipulated timeline. This process shall get escalated till the Chief Minister's office & will be available to public via live coverage on TV & Social networks with complete transparency.

4. The people representative & the Government officials who solve the public problems and complaints within the stipulated timeline shall be rewarded suitably & will be awarded points. The number of points shall be an indicator & eligibility for contesting in the next elections. The accumulated points shall be one of the criteria for the officials promotion to next higher position (similar to corporate ticketing, timelines and targets)

5. Minimum number of predefined points are to be scored with efficient working. Inefficiency at work and non-performers shall be eligible for disciplinary action and punitive wage deduction.
6. It will be mandatory for all Government workers to wear uniform with badges indicating their Full name, post, position, categorized based on different ministries. This will help the public to identify the various department workers properly.
7. All Government offices and departments will have attendance registration through biometric, Wi-Fi, CCTV Camera, which will be accessible by public locality wise.
8. All the activities in Vidhanasoudha its, plans, works, discussions, proceedings of the sessions, with authentic visuals and other documentation shall be projected on a big screen like TV studio in Vidhanasoudha and all the debates will happen on this basis.
9. All Ministers, MLA's , Corporators, Taluk & village panchayat members and Government department workers will be connected visually (Live) to Vidhanasoudha at the time of the session with authentic documents of various projects. The entire process shall be compulsorily broadcasted live on TV and social network for people with "Phone-in facility" to participate in sessions.

10. All Government projects, every tender proceedings its discussions and decisions will be completely done through on line. Any personal interactions with the authorities and tender allocated contractor/agency will be strictly prohibited. The entire process shall be compulsorily broadcasted live on TV, social network & will be available for public viewing
11. All payments will be done to the contractor based on authentic visual documents/bills and attendance details. The contractor shall publish/submit the attendance registration details of the laborers involved in the project through biometric, CCTV Camera, RFID to concerned authorities and public. There will be no need for the contractor to have physical presence/interactions with concerned Government officials for payment.
12. Public shall have access to live coverage on TV & Social networks (constituency wise) with complete transparency on every Governments project, work in progress, expenditure & spending of its officers & contractors, project timelines & different stages of project development.

13. The people representatives will have to mandatorily publish in advance to public, their day to day engagement & calendar of events in their respective constituency's mobile applications and social networking.
14. Monthly interaction session between the citizens, elected representatives and Government officials shall be available to public in their respective constituencies through TV channels & social network with authentic visual documentation.
15. The chief minister and the respective minister shall do continuous monitoring and conduct surprise visits (raids) from time to time. This process shall be video recorded and live coverage facility will be available for public.
16. Whenever Government officials are transferred, it shall be done with proper reason, documentation and proofs with live coverage.
17. All Government departmental interviews & selection process shall be telecasted live on TV for public viewing.

18. All details of tax collections and revenues will be made public area wise monthly with authentic documentation.
19. Public shall have continuous access to elected representatives & Government officials salaries, facilities & all Government expenditure (Housing, boarding & lodging, travel, medical, all other allowances & benefits) Approvals will be based on genuine reasons and authentic visual documentation uploaded by elected representative & Government officials in public domain.
20. Former elected representatives and retired Government officials can voluntarily surrender their pension similar to voluntarily surrendering of gas subsidy.
21. The money accumulated from the voluntary surrendering of pension shall be utilized for the development of homeless and old age homes.
22. All Government projects will be open to public on the date of completion of the project with relevant approvals from the concerned authorities. No Inauguration/ functions, People representatives' participation will be strictly prohibited.
